.50% APY on balances \$25,000 and above

.45% APY on balances of \$5,000 to \$24,999.99

**.40% APY** on balances of \$1,000 to \$4,999.99

.35% APY on balances up to \$999.99

Higher yields are available on share certificates and IRA share certificates purchased with a minimum of \$1,000.
